Each year, an election takes place in three of our nine districts to elect a director to represent that district on our board. The election process ensures that every member has a voice in the operation of this organization and that any member in good standing may seek election for the Board of Directors.

Nominations are now open for the board in Districts 4, 5 and 9.

### **DISTRICT INFORMATION:**

**District 4 –** Serving Minnesota townships: Farming, Zion, Munson, Paynesville, Eden Lake and Luxemburg in Stearns County.

**District 5** – Serving Minnesota townships: Bangor, Glenwood and Grove Lake in Pope County; Raymond, Getty, Grove, North Fork, Lake George, Spring Hill, St. Martin, Crow Lake, Crow River and Lake Henry in Stearns County; and Roseville Township in Kandiyohi County.

**District 9 –** Serving Minnesota townships: St. Joseph, Wakefield, Rockville and Maine Prairie in Stearns County.

### **DIRECTOR QUALIFICATIONS:**

- Nominees must be a member of the Cooperative and a primary resident of the district they wish to represent.
- Nominees cannot be employed by, or have financial interest in, a competing enterprise.
- Nominees must have the time available to attend a minimum of 12 regular daytime board meetings, and additional meetings and training sessions as needed.

## **CEO MESSAGE**WINTER RELIABILITY

As winter officially settles in, I want to talk about reliability of the electric grid and what we at Stearns Electric are doing to prepare for our coldest season of the year.

You might have read or heard some recent headlines that question the reliability of the nation's electricity supply this winter. In November, the North American Electric Reliability Corporation (NERC) released its annual winter reliability assessment, which stressed the need to improve the reliability of North America's power grid. While these headlines are attention grabbing, I want to reiterate that here in Minnesota and across the Midwest, our wholesale power provider, Great River Energy (GRE), in partnership with other generation and transmission companies in our region, spend countless hours preparing the power grid to ensure a high level of reliability, especially in the winter.

Here are a few other headlines, or key takeaways, I want to reiterate this month:

**GRE's generation facilities are adequately prepared for the coldest days of the year.** GRE continues its transition to carbon free energy to meet Minnesota's Carbon Free by 2040 mandate. GRE is adding many renewable energy generation sources to its portfolio and it also maintains several fuel-based peaking stations that can produce precise amounts of energy when needed. These peaking facilities play an important role kicking in immediately to produce more energy when demand is high, generally on the coldest days of the year.

GRE has also equipped three of its existing generation facilities with backup fuel options, allowing the utility to generate electricity with fuel oil or natural gas. This optional fuel switching better ensures both affordability and reliability in extreme weather scenarios. Recently, the Minnesota Public Utilities Commission approved GRE's plan to integrate diesel fuel energy at its natural gas peaking plant near Cambridge, bringing the total dual fuel generating facilities up to four. This is very beneficial to energy consumers in Minnesota.

In Minnesota, we work together to help maintain electric reliability and affordability. GRE and its 27 member-owned cooperatives, including Stearns Electric, have a wide network of members like you signed up for load control programs. Participating members elect for their qualifying electric loads to be curtailed during times of highest energy demand, reducing overall demand and improving reliability in our region. In return, participants pay a reduced energy rate.

### Transitioning to carbon free energy generation too quickly poses challenges.

As utilities across the country work to meet carbon free energy generation mandates, it is important that we don't shut down fossil fuel generation facilities prematurely. Doing so has potential to impact the affordability and reliability of electricity that we have come to expect. Reports like the recent one published by NERC continue to help guide the industry on this historical new path toward carbon-free energy. In fact, the New York Independent System Operator announced in November it will keep four peaking plants operating past their expected 2025 retirement date to maintain adequate electric reliability.

### BOARD MEETING HIGHLIGHTS


The regular meeting of the Board of Directors of Stearns Electric Association was called to order on Thursday, October 26, 2023, at 1:02 p.m. at the St. Joseph office of Stearns Electric Association.

Highlights of the meeting include:

- Manager of Energy Services, John Pantzke presented on electric vehicles within the Co-op's system.
- Vice Presidents Vicky
   Herkenhoff and James Pachan
   reviewed the current strategic
   plan and corporate scorecard.
- CEO Matt O'Shea presented an update on the headquarters facility progress. The construction management contract is being reviewed.
- CEO O'Shea reviewed approval of the power purchase contract extension to 2055 by GRE all-requirements members. GRE's 2024 preliminary budget was also discussed, which includes a 2.2% rate increase for Stearns Electric while WAPA rates will remain the same.
- Board members directed Cooperative leadership to continue pursuing the Employee Retention Credit.
- Board members approved the acceptance of equipment and machinery to be used as collateral for an E3 loan through GRE that Stearns Electric is assisting with.
- Director Greg Blaine discussed the GRE Board approved changes to GRE Articles of Incorporation and Bylaws, which will be voted on next month.

### **OPERATION ROUND UP® DISTRIBUTES \$74,400 IN NOVEMBER**

The Stearns Electric Association Trust Board met on Wednesday, November 1 to award funds through the Cooperative's Operation Round Up® (ORU) program. They distributed \$74,400 to 62 local organizations and charitable causes. This included donations to Central Minnesota's 19 food shelves and 10 area holiday gift-giving organizations.

Through the ORU program, members of the Cooperative round up their monthly electric bills to the nearest dollar. The rounded-up funds (between  $1\c$  and  $99\c$ ) are placed in a trust fund that is administered by the Trust Board.

Any local non-profit organization or charitable cause can apply for funding. The next deadline is Friday, February 23, 2024.

### WHY DID YOU DECIDE TO INSTALL AN ENERGY-EFFICIENT CATTLE WATERER?

When we built our new cattle barn in 2021, we installed our new energy-efficient waterers along with two smaller ones in an older barn. It gave us more flexibility not having to thaw water in the winter as the old waterers were steel.

### WHAT HAS BEEN THE BIGGEST BENEFIT OF USING THE NEW WATERERS?

The time savings from not having to thaw the water when it gets really cold. We now have up to an hour of time back that we can use for more important tasks on the farm.

### ARE THERE ANY INCONVENIENCES OF USING THE NEW WATERERS?

The initial cost of installing the new waterers was really the only inconvenience, but that investment has now paid for itself.

### **HOW MUCH DID YOU RECEIVE IN REBATES?**

We received a rebate of \$75 per waterer installed.


### **HOW MUCH MONEY HAVE YOU SAVED?**

For the specific waterer we have, we pay about half of what we did previously with the old waterer, which is a savings of approximately \$35 per month.

### **HOW MUCH ENERGY HAVE YOU SAVED?**

We save nearly 125W of energy per heating hour as the heating element in the new waterer operates with a lower heating element wattage.





## STEARNS ELECTRIC ENERGYWISE REBATE AGRICULTURAL LIVESTOCK WATERER

The Agricultural Livestock Waterer Rebate is for the installation of insulated or energy-free livestock waterers in place of standard electric waterers. Livestock waterers provide fresh water in a trough but keeps the water fresh and clean by limiting the amount of water allowed to sit in the trough when not in use.

### **REBATE REQUIREMENTS:**

- Evaluation must be complete before funds will be issued for the rebate.
- Members and vendors must submit itemized equipment invoices, rebate applications and manufacturer equipment specifications.
- The Cooperative reserves the right to conduct random inspections of installations.
- Rebates must be applied for within 12 months of invoice date.
- Project must comply with all program-specific rules and qualifications.
- The member is responsible for checking with the Cooperative to determine funding and availability to verify program parameters.

\*The maximum rebate shall not exceed 25% of materials cost OR project cost, up to \$10,000 per member.

Stearns Electric offers residential, commercial, industrial and agricultural rebates for our member-consumers. # EMPLOYEE CHARITY EVENT RAISES NEARLY \$6,500

Stearns Electric held the 16<sup>th</sup> Annual Employee Charity Event on November 15 where employees raised a record-breaking \$6,426 for this year's employee-selected organization: Soldier's 6. Donations were raised via a silent auction, direct contributions and other activities throughout the day.

Soldier's 6 is a Minnesota-based organization that provides specially trained K-9's to honorably discharged veterans, police officers, firefighters, paramedics, correctional officers and 911 dispatchers. These K-9's become 'Battle Buddies' that help guide their human through the difficult days in life.

"As a local, member-owned electric utility, we value the communities and the people we serve. The annual Charity Event is one way that we can bring all our employees together to live out our Stearns Electric value of meaningful community involvement," CEO Matt O'Shea explained.


### NOTICE TO ALL IRRIGATION MEMBERS

## COOKING CORNER FRITO PIE

### **INGREDIENT**

- 1 lb turkey or beef
- 1 small onion, finely diced
- 1 Tbsp garlic, minced (or substitute 1 tsp garlic powder)
- 15 oz can kidney or black beans, partially drained

15 oz can diced tomatoes

- 1 packet taco seasoning
- 2 tsp chili powder
- 1 bag Fritos corn chips
- 2 C shredded cheddar or Mexican cheese

### **DIRECTIONS**

Brown meat and drain. Add onion and garlic and cook until soft. Add beans, tomatoes, chili powder, taco seasoning and water quantity that is designated on seasoning packet. Simmer for 10 minutes. Cover the bottom of a 9x13" pan with Fritos corn chips, setting aside approximately 1½ C of Fritos for later. Sprinkle some cheese lightly over the chips, then cover chips and cheese with all of the meat mixture. Sprinkle remaining cheese over the top of the meat mixture and finally, add what's left of the corn chips on the top. Bake at 350 degrees until fully heated through. Enjoy!
